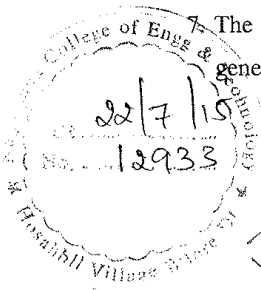
**Sub: Grant of Autonomous Status to College- reg..**

Pursuant to the Executive Council Resolution cited at Ref (1) above, in exercise of powers conferred upon Visvesvaraya Technological University by the VTU ACT cited at Ref (3) above, the **Nagarjuna College of Engineering & Technology, Bengaluru** a Permanently affiliated college, is provisionally granted '**Autonomous Status**' for period of SIX YEARS starting from the academic year 2015-16 to 2020-21, subject to the following conditions.

### Conditions:


1. The Autonomy is not conferred once and for all. It has to be continuously earned by the College as per provisions of the statute.
2. The Academic Autonomy granted is subject to obtaining concurrence of University Grants Commission, New Delhi.
3. In the event of concurrence of the University Grants Commission not being received within period of one year or before the start of the next academic year, the college shall revert to the non-autonomous status.
4. The college shall abide by the Act, Statutes, rules and regulations, of the Visvesvaraya Technological University.
5. The college shall get its programmes accredited by the National Board of Accreditation and NAAC as and when mandated by UGC.
6. The college shall send annual self-evaluation reports to the University.
7. The college shall send the list of admitted candidates to the University for approval and generation of University Seat Numbers Immediately after reconciliation.

8. The college shall send the list of successful candidates approved in the Academic Council of the college for conferment of Degrees or Certificates by the University within prescribed date(s).
9. The fee shall be collected as per University and Government notifications issued from time to time.
10. Any other notification issued by the University from time to time shall be followed.
11. The Autonomous Status shall be applicable for both Undergraduate and Postgraduate courses.
