

Section 4: Items for Approval

4.1 Approval of Revised Research Promotion Policy.

The institution is promoting research and development among the faculty members through the research promotion policy. In order to further strengthen the research activities, and to encourage more number of faculty members participating in the research activities, the Research Promotion Policy is revised and presented to the GB.

GB discussed the draft of the revised Research Promotion Policy and authorized COO Mrs. Bhanu Chaithanya and Principal to finalize the proposal after detailed discussions.

4.2 Approval of Student Enrichment Policy for promoting NPTEL Courses / MOOCS / Conferences/Hackathons/Academic Competitions, etc. among students.

The institution is supporting the students in curricular, co-curricular and extra-curricular activities. In order to formalize the process of support for student activities and achievements, the Student Enrichment Policy is designed for promotion of NPTEL Courses / MOOCS / Conferences / Hackathons / Academic Competitions, Higher Education through GATE, etc.

GB discussed the draft of the Student Enrichment Policy and authorized COO Mrs. Bhanu Chaithanya and Principal to finalize the proposal after detailed discussions.

4.3 Approval of Report of Student Satisfaction Survey conducted by IQAC for the Academic Year 2022-23.

Member Secretary presented the Student Satisfaction Survey (SSS) data for Academic Year 2022-23. The Student Satisfaction Survey was conducted by IQAC as per the requirements of NAAC. Member Secretary informed the GB that 85% of students have expressed their satisfaction towards curricular, co-curricular and extra-curricular activities of the institution.

GB approved the Report of Student Satisfactory after detailed discussions on the suggestions of the students provided in the survey. GB informed the Principal to take suitable measures to address the concern of the students expressed in the survey.

4.4 Approval of Report of Internal Academic Audit conducted by IQAC for the Academic Year 2022-23.

Member Secretary informed that, IQAC has conducted Internal Academic Audit as per the requirements of NAAC for the Academic Year 2022-23 and also presented the report to the GB members.

4.6 Approval of recruitment of faculty members against the vacancy positions in various departments for the academic year 2023-24.

It is proposed to recruitment faculty members in various departments for the academic year 2023-24 in order to fill the faculty positions against the vacancies. GB authorized the Principal to take measures to recruit the faculty members as per the requirements through Board of Appointments and the guidelines of AICTE and VTU.

The GB approved the recruitment of required faculty members against the vacancy positions.

Section 5: Any other Items

5.1 Approval of proposal for increase in intake and introduction of new programmes from the Academic year 2024-24.

It is proposed to increase the intake in B.E. in Computer Science and Engineering from 180 to 240 and B.E. in CSE (Artificial Intelligence and Machine Learning) from 60 to 120. Further, it is proposed to start a new programme in Master of Computer Applications (MCA) with an intake of 60. Further, it is proposed to reduce the intake in M.Tech in Structural Engineering from 24 to 12.

GB approved the proposed increase in intake in BE in Computer Science and Engineering from 180 to 240, BE in CSE(AIML) from 60 to 120 and starting of new MCA programme in the institution from the Academic year 2024-25. GB also approved the reduction in intake in M.Tech in Structural Engineering from 24 to 12.
